

## Sarclisa® (isatuximab-irfc) (Intravenous)

### I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [NDC Unit]:

- Cycle 1, every week x 4 doses, followed by Cycle 2, and beyond, every 2 weeks
  - Sarclisa 100 mg/5 mL single-dose vial for injection: 4 vials per dose
  - Sarclisa 500 mg/25 mL single dose vial for injection: 2 vials per dose

#### B. Max Units (per dose and over time) [HCPCS Unit]:

- Cycle 1 every week x 4 doses, followed by Cycle 2, and beyond, every 2 weeks
  - 110 billable units per dose

### III. Initial Approval Criteria <sup>1,3</sup>

Coverage is provided in the following conditions:

- Patient is at least 18 years of age; **AND**
- Patient is not refractory to previous treatment with anti-CD38 therapy (i.e., daratumumab, etc.) [*Note: refractory is defined as progression on or within 60 days after the end of prior anti-CD38 treatment OR failure to achieve at least minimum response to treatment*]; **AND**

#### Multiple myeloma † ⊕ <sup>1-3</sup>

- Used in combination with pomalidomide and dexamethasone after at least two prior therapies including lenalidomide and a proteasome inhibitor (e.g., bortezomib, carfilzomib, ixazomib, etc.)

#### IV. Renewal Criteria <sup>1</sup>

Coverage can be renewed based upon the following criteria:

- Patient continues to meet indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in section III; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: severe infusion-related reactions, neutropenia, secondary primary malignancies, etc.

#### V. Dosage/Administration <sup>1</sup>

Indication	Dose
Multiple Myeloma	<p>Combination therapy with pomalidomide and dexamethasone:</p> <ul style="list-style-type: none"><li>▪ 10 mg/kg of actual body weight given as an intravenous infusion:<ul style="list-style-type: none"><li>– Weekly Cycle 1 (four doses total; Days 1, 8, 15, &amp; 22)</li><li>– Every two weeks Cycle 2 and beyond (two doses per cycle; Days 1 &amp; 15)</li></ul></li></ul> <p><i>*Each treatment cycle consists of a 28-day period. Treatment is repeated until disease progression or unacceptable toxicity.</i></p>
