### I. Length of Authorization

Coverage will be provided for 12 months and may be renewed.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [NDC Unit]:

- 50 mg implant: 1 per 12 months

#### B. Max Units (per dose and over time) [HCPCS Unit]:

- 1 billable unit per 12 months

### III. Initial Approval Criteria <sup>1,2</sup>

Coverage is provided in the following conditions:

#### Advanced Prostate Cancer †

- Patient is 18 years or older

† FDA Approved Indication(s)

### IV. Renewal Criteria <sup>1</sup>

Coverage can be renewed based upon the following criteria:

- Patient continues to meet indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in section III ; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**

- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: QT/QTc interval prolongations, cardiovascular disease, spinal cord compression, urinary tract obstruction, severe hyperglycemia/diabetes, etc.

Indication	Dose
Prostate Cancer	One 50 mg implant inserted subcutaneously every 12 months
