I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

II. Dosing Limits

A. Quantity Limit (max daily dose) [NDC Unit]:

- Jemperli 500 mg/10 mL single-dose vial:
 - Initial: 1 vial every 21 days x 4 doses
 - Subsequent: 2 vials every 42 days

B. Max Units (per dose and over time) [HCPCS Unit]:

- Initial: 50 billable units (500 mg) every 21 days x 4 doses
- Subsequent: 100 billable units (1000 mg) every 42 days

III. Initial Approval Criteria¹

Coverage is provided in the following conditions:

• Patient is at least 18 years of age; AND

Universal Criteria

 Patient has not received previous therapy with a programmed death (PD-1/PD-L1)-directed therapy (e.g., cemiplimab, avelumab, nivolumab, atezolizumab, durvalumab, pembrolizumab, nivolumab/relatlimab-rmbw, etc.), unless otherwise specified ^Δ; AND

Endometrial Carcinoma (Uterine Neoplasms) † ‡ 1,3,10

- Used in combination with carboplatin and paclitaxel; AND
 - \circ $\;$ Used as primary treatment for patients with stage III-IV tumors; OR
 - $\circ~$ Used as adjuvant the rapy for patients with stage III-IV endometrioid adenocarcinoma; \mathbf{OR}
 - Used first-line for recurrent disease; AND

- Patient does not have isolated metastases; **OR**

Mismatch Repair Deficient (dMMR)/Microsatellite Instability-High (MSI-H) Cancer † 1-4,9

- Patient has mismatch repair deficient (dMMR) or microsatellite instability-high (MSI-H) cancer as determined by an FDA-approved or CLIA-compliant test **\$**; **AND**
- Used as a single agent; AND
 - Used for disease progression, persistent disease, or recurrence following prior treatment; AND
 - Patient has endometrial cancer that has progressed on or following prior treatment with a platinum-containing regimen in any setting *†*; OR
 - Patient has solid tumors; **OR**
 - Used as initial therapy **‡**; **AND**
 - Patient has one of the following cancers:
 - Endometrial Carcinoma (excluding patients with isolated metastases)
 - Appendiceal Adenocarcinoma Colon Cancer
 - Colorectal Cancer (CRC) (*Note: neoadjuvant therapy is allowed for resectable liver and/or lung metastases OR for clinical T3, NAny; T1-2, N1-2; T4, NAny; or locally unresectable or medically inoperable disease for rectal cancer only*)

IV. Renewal Criteria¹

Coverage may be renewed based upon the following criteria:

- Patient continues to meet the universal and other indication-specific relevant criteria identified in section III; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: severe infusion-related reactions, severe immune-mediated adverse reactions (e.g., pneumonitis, hepatitis, colitis, endocrinopathies, nephritis with renal dysfunction, dermatologic adverse reactions/rash), complications of allogeneic hematopoietic stem cell transplantation (HSCT), etc.

• Patients whose tumors, upon re-biopsy, demonstrate a change in actionable mutation (e.g., MSS initial biopsy; MSI-H subsequent biopsy) may be eligible to re-initiate PD-directed therapy and will be evaluated on a case-by-case basis.

	ns Administer 500 mg intravenously every three weeks for doses 1 through 4, followed subsequent doses of 1,000 mg every six weeks (dose 5 begins three weeks after the dose) until disease progression or unacceptable toxicity
