I. Length of Authorization

Coverage will be provided for a single injection into each affected eye and may not be renewed.

II. Dosing Limits

A. Quantity Limit (max daily dose) [Pharmacy Benefit]:

- Jetrea 0.375 mg single use vial: 1 vial per eye

B. Max Units (per dose and over time) [Medical Benefit]:

- 6 units one time only

(Max units are based on administration to both eyes)

III. Initial Approval Criteria

Coverage is provided in the following conditions:

Symptomatic Vitreomacular Adhesion (VMA) †

- Patient is 18 years or older

† FDA Approved Indication(s)

IV. Renewal Criteria

Coverage cannot be renewed.

V. Dosage/Administration

Indication	Dose
Vitreomacular adhesion	0.125 mg (0.1 mL) administered by intravitreal injection to the affected eye once as a single dose. For treatment of bilateral VMA, a waiting
