



# Lutathera® (lutetium Lu 177 dotatate) (Intravenous)

## I. Length of Authorization

Coverage will be provided for 1 year (4 doses only) and may NOT be renewed.

## II. Dosing Limits

### A. Quantity Limit (max daily dose) [NDC Unit]:

- N/A

### B. Max Units (per dose and over time) [HCPCS Unit]:

- 200 billable units (7.4 GBq = 200 mCi) every 8 weeks for a total of 4 doses

## III. Initial Approval Criteria<sup>1,3,4</sup>

Coverage is provided in the following conditions:

- Patient is at least 18 years old; **AND**

### Universal Criteria

- Patient has a negative pregnancy test (in females); **AND**
- Patient's disease is somatostatin receptor-positive in all tumor lesions (OctreoScan uptake  $\geq$  normal liver); **AND**
- Patient has well-differentiated disease with a Ki67 labeling index score of  $\leq 20\%$ ; **AND**
- Patient has not received any long-acting somatostatin analogues (e.g., octreotide LAR, pasireotide LAR, lanreotide depot, etc.) within the previous 4 weeks OR short-acting somatostatin analogues (e.g., octreotide, pasireotide, etc.) within 24 hours prior to therapy; **AND**
- Will be used in combination with a long-acting somatostatin analog (e.g., octreotide LAR, lanreotide depot, etc.) given as a single-injection (between 4-24 hours) following each Lutathera infusion; **AND**

### Gastroenteropancreatic Neuroendocrine Tumors (GEP-NETs) † ⊕

- Patient has progressive locally advanced or metastatic disease; **AND**
- Patient's disease has progressed on long-acting octreotide or lanreotide

## Carcinoid Tumors †

- Patient's disease has progressed on long-acting octreotide or lanreotide; **AND**
  - Patient has bronchopulmonary/thymic disease; **AND**
    - Used as subsequent therapy for unresectable or metastatic disease; **OR**
    - Used as primary therapy for metastatic disease with clinically significant tumor burden and low grade (typical) histology, evidence of progression, intermediate grade (atypical) histology or symptomatic disease; **OR**
  - Patient has locally advanced gastrointestinal disease and/or distant metastases; **AND**
    - Patient has progressive disease or clinically significant tumor burden; **OR**
  - Patient's symptoms are poorly controlled; **AND**
    - Used in combination with telotristat for persistent diarrhea; **OR**
    - Used in combination with octreotide LAR or lanreotide for persistent symptoms (i.e., flushing, diarrhea, etc.)

## Pheochromocytoma/Paraganglioma †

- Used for treatment of locally unresectable or metastatic disease

## V. Dosage/Administration<sup>1</sup>

Indication	Dose
All indications	<ul style="list-style-type: none"><li>• 7.4 GBq (200 mCi) every 8 weeks for a total of 4 doses. Administer a single dose of long-acting somatostatin analog between 4 to 24 hours after each Lutathera dose. (Long-acting somatostatin analog may not be repeated until after the next scheduled dose of Lutathera to provide the 4-week drug-free interval. Short-acting octreotide may be administered up to 24 hours prior to each Lutathera dose)</li><li>• Initiate recommended intravenous amino acid solution 30 minutes before Lutathera infusion; continue during and for 3 hours after infusion.</li></ul> <p><i>(Lutathera is a radiopharmaceutical; handle with appropriate safety measures to minimize radiation exposure. Use waterproof gloves and effective radiation shielding when handling. Lutathera should be used by or under the control of physicians who are qualified by specific training and experience in the safe use and handling of radiopharmaceuticals, and whose experience and training have been approved by the appropriate governmental agency authorized to license the use of radiopharmaceuticals.)</i></p>
