### I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [NDC Unit]:

- Lumakras 120 mg tablets: 8 tablets per day

#### B. Max Units (per dose and over time) [HCPCS Unit]:

- 960 mg per day

### III. Initial Approval Criteria <sup>1</sup>

Coverage is provided in the following conditions:

- Patient is at least 18 years of age; **AND**

#### Universal Criteria <sup>1</sup>

- Patient will avoid concomitant therapy with all of the following:
  - Coadministration with systemic gastric acid-reducing agents (e.g., PPIs or H<sub>2</sub> receptor antagonists), or if acid-reducing therapy is unavoidable, locally acting antacids may be considered; **AND**
  - Coadministration with strong CYP3A4 inducers (e.g., rifampin, carbamazepine, St. John's Wort, etc.); **AND**

#### Non-Small Cell Lung Cancer (NSCLC) † $\Phi$ <sup>1-3</sup>

- Patient has recurrent, advanced, or metastatic disease (*excluding locoregional recurrence or symptomatic local disease without evidence of disseminated disease*) or mediastinal lymph node recurrence with prior radiation therapy; **AND**
- Patient has *KRAS G12C* mutation positive disease as detected by an FDA-approved or CLIA compliant test<sup>❖</sup>; **AND**

- Used as a single agent; **AND**
- Used as subsequent therapy

#### IV. Renewal Criteria <sup>1</sup>

Coverage can be renewed based upon the following criteria:

- Patient continues to meet universal and other indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in Section III; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: interstitial lung disease/pneumonitis, hepatotoxicity, etc.; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread

#### V. Dosage/Administration <sup>1</sup>

Indication	Dose
Non-Small Cell Lung Cancer	Administer 960 mg (eight 120 mg tablets) orally once daily until disease progression or unacceptable toxicity.
